
How DPS Works

Create New Or Modify Existing Client




Once you sign on, you either create a new client or modify an existing client.

Select Area Of Law



If you are creating a new client, the next screen you will see is the Area Of Law. You select an Area Of Law, such as Estate Planning.


Select Document



You then select the particular document you want to prepare, such as a Will.


How DPS Works

Select Guide



Once you select the Area Of Law and Document, you then base the document you want to create based on one of the many standard guides that are available in DPS. A guide will pre-answer many questions that are asked by DPS, thereby making your use of DPS easier and faster.

Enter Information



DPS will then guide you through the document, prompting you for the proper client information and decisions. It will only ask you the questions necessary to prepare the document.

Produce Document



Once you have gone through this process, you can produce your document or tax return either as a PDF, a Word or a Word Perfect document.

DPS Features

- Enter information once and it is linked:
 - Within that Document and
 - Within other documents in that Area Of Law

Built into DPS are a number of features that I thought would be useful in my practice. Information is entered only once with that data linked to other fields in that document and to other documents in that area of law. As an example, once you enter the name of a child in a Will, that child's name is also in the Revocable Trust document and all other estate planning documents.

Edit Provisions






You can edit the language in any of the provisions of the document if you want different language, rather than the standard DPS language. The provisions are edited by preparer so that you can have different edited provisions than your partner.

Produce Document

- Formats available
 - PDF
 - Word format
 - WordPerfect format

If you have a situation where DPS does not produce exactly the document you want, you can produce it in Word or Word Perfect format rather than a PDF. This allows you to edit the language for that particular document and customize it for that particular client.

For example, by indicating the client is male, all of the pronouns for the client and client's spouse are appropriate. It also formats dates, state names, etc., on the screens and in the documents.</p>
